Dear W. Okuma

Last English mail brought
me a telegram from London by
Hong Kong telling me the New
Japanese loan had been a
great success that four
times the amount was
offered. It is possible you
may know this already - but at
all events I offer you my
Congratulations on such
a success.

When I was last at Osaka
I saw W. P. - He wished
me to speak to you about
permission to export silver
bars for him; but I have
never had an opportunity

of seeing you. I do not
wish to invest our meeting
with anything of an official
nature. merely a private
Conversation. Could you
come down & break fast with
us some day. one of our
European officers in the
Barracks can act as interpreter.

I have a plan in my
head for avoiding losses
such as those your friends
have suffered by these
Gambler rascals. Bowles
& Brothers &c. I would also
like to talk with you about
this. Unless something be
done you will find other
cases not only abroad but
also in Japan.

I know quite well that
Finance is not your par-
ticular business. but I

also know you have very
clear & good judgments
in all these cases & may
have occasion to dis-
cuss them with others
